PRESIDENT'S MESSAGE FOR JUNE, 2016

How quickly time passes! It doesn't seem that it's been over six months since I announced to you that Koenig's had informed us that the restaurant was permanently closing and that our venue for SOAR's luncheons for over twenty years would cease to exist.

Within weeks of my announcement, I received comments from many of you, who had attended our luncheons over the years, expressing your disappointment and recalling memories of luncheons gone by, guest speakers who had appeared and members who were no longer with us.

Based upon the consensus of the opinions that were received, it was apparent that the tradition of SOAR sponsoring periodic luncheons for the benefit of its members who reside within the metropolitan area should be preserved. Accordingly, the Board of Directors resolved to seek a suitable venue to continue these traditional luncheons that had been so well attended at Koenig's over the years. At a meeting of the Board, several venues in Nassau, the Bronx and Queens were preliminarily suggested and considered, based upon various criteria, such as cost, the menu, location, access and private parking.

With these factors in mind, I asked Ed Rybak, our first Vice President, to contact the owners of Verdi's Restaurants, which has catering establishments in Nassau and Queens, to evaluate the suitability of both locations for our luncheons. Ed reported his findings to the Board, which after due deliberation, concurred with Ed's recommendation that Verdi's in Queens be selected as the venue for the June 7, 2016 luncheon.

At another site in this newsletter, you will find additional details about the luncheon and its cost, which is \$42.00 per person, including taxes and gratuities, if paid at the door.

I've visited Verdi's, met with the owner and savored some of the items that will be served on our luncheon menu. It was in all respects, a pleasant and worthwhile experience. I hope to be able to share the SOAR luncheon experience again with you and your guest at Verdi's on June 7th.

About the same time that I received the disappointing news from Koenig's, I received some very uplifting news from two of our Board members; namely, Jesse Peterman and Larry Loesch. By way of an introduction, a continuous problem for retiree organizations such as SOAR, has been our inability to interact directly with the NYPD, in general and more particularly, with regard to our ability to contact active members as they approached their retirement. Succinctly, SOAR and similar retiree organizations had no direct means to reach out through the Police Department bureaucracy to contact the only potential source for new members. Inevitably, the number of new "recruits" to retiree organizations has continued to dwindle.

Under the auspices of Commissioner Bratton and the collective efforts of Captain Robert Sans-Caset, the current Director of the Pension Section of the NYPD and SOAR Directors Peterman and Loesch, a program has been instituted by the NYPD to mail a letter on Police Department stationary to all NYPD retirees, who are potential members of SOAR. The letter, which is authored by me, serves to introduce SOAR from its twenty-five year historical perspective and sets out the inherent benefits to the recipient of maintaining a continuing organized association with other retired police officers via membership in an organization that fosters and supports their common interests.

I am pleased to inform you that the mailing, which was sent out in late January, reached over Five Thousand retirees of the NYPD that are prospective members of SOAR. To date, we have received applications and dues from over 160 new members!

In my opinion, this voluntary association by the Police Department with a retiree organization may symbolize a recognition by the NYPD that in a time when unruly factions seek to denigrate and vilify police officers in the eyes of a whimsical public, there is a viable association with a cadre of retired police officers to whom "Blue Lives" will always matter, which can be developed and nurtured. We can certainly seek ways to build on this bridge between "active" and "retired" police officers.

In recognition of this historic joint venture, I have asked Captain Sans-Caset to be our guest speaker at the luncheon at Verdi's on June 7th. At that time, he will address the current recruitment program as well as other pertinent pension issues of concern to us all.

I urge you to attend and take this opportunity to meet many of the new members, who we hope will join us. As an inducement, if you purchase your ticket(s) in advance from SOAR by mail prior to May 31, 2016, the price will be reduced to \$35.00 per ticket. The organization will incur the addition cost as our way of saying "Thanks". On June 8, 2016, the day after our luncheon, our companion organization in the National 10-13 Clubs of America, the New York 10-13 Club will hold its annual golf outing at the Clearview Country Club. NYC and Municipal Labor Committee Agree To Increase Health Care Cost Effective July 1, 2016

As part of New York City's efforts to generate \$3.4 billion in health care savings, the Municipal Labor Committee (MLC) and the New York City Office of Labor Relations agreed to significant changes to NYC's active and retiree's health plans effective July 1, 2016.

plans effective July 1, 2016. According to NYC, although the new agreement will increase copays for specialty care and emergency room visits for both active and retired NYC employees including NYPD retirees, routine checkups and preventive care tests will be more affordable when using health plan doctors.

Beginning July 1, 2016, the current hospital emergency room co-payment of \$50.00 per visit is being raised to \$150.00 per visit. If a patient is admitted to the hospital from the emergency room, the entire co-pay will be waived.

For a physician speciality care visit, the current \$20.00 will be raised to \$30.00, while the primary care and mental health co-pays remain at \$15.00. Preventive care visits and procedures will have no co-pay.

Furthermore, to provide access to low cost and primary care, NYC entered into an agreement with EmblemHealth to provide access to all the physicians at their 36 Advantage Care Physicians locations in and around the City with no co-pays.

However, to help address the costs and over-utilization of high cost radiology procedures like MRIs and CT scans, the co-pay is being increased to \$50.00 and diagnostic laboratory testing and

The Art of the Scapegoat

Scapegoat: A person or group that is made to bear blame for others'; a definition all too familiar to a wide scope of affected individuals ranging from race, ethnicity to even religion. Even so, this modern age has seen that phenomenon broadened even further, with professions, more particularly 'law enforcement' professionals now drawn into this insidious category. Killer cops? Some collective diabolical 'mind set' to murder and oppress people based on some sick racial motive? The actions of an individual cop, even if tragically unintentional, presented as evidence of both personal and collective culpable intent, coupled with limited means of effective repudiation? All issues that need answers.

Consider this: In 2015 police officers nationwide, after enumerable law enforcement public contacts and virtually millions of arrests, many against dangerous armed felons, killed just fewer than 1,000 people (NYPD had less than 10), the overwhelming majority in completely justifiable circumstances. A significant number but nonetheless it appears that all that's needed to undermine, and even in some cases condemn all police officers is an event, any cherry picked isolated event, coast to coast, that feeds into the "all the news that's fit to sell' category, even when of the 'hands up', 'don't shoot' manufactured category. The art of the scapegoat; cops lives ruined, examples made of pre judged officers based on a critical pre conceived subjective script and all performed with relentless skill and remarkable impunity. A host of unchallenged hypocrites accusing cops of stereotyping people while doing the same to them in the very same breath, but with far more dire consequences towards those personally targeted "to be made examples of".

In contrast, according to reputable studies, far more people die in the hands of 'medical professionals. Indeed nationally, medical malpractice deaths range from over 200,000 from doctor errors alone, to 440,000 per year when all other categories are factored in. Further, with sociological factors including race, income and 'social standing' added in, disparities in survival rates become even more despairingly acute. A profession ripe for a media event and broad attacks by critics? Think again! Can anyone even imagine any individual medical professional subjected to a headline, some even fictitious 'to provide impact' attacking their personal character and professional reputation without public lament and a parade of lawsuits? Better still, nameless components of the Goldman Sachs Financial Empire promoted a "flawed" financial product, one that helped create chaos, with even international implications and no personal information is forthcoming as to fault and/or possible culpability? Where is the 'hands out', 'don't short', headline?

Some might argue that the 'public' nature of police/public contacts are more constant and visible and that mistakes, abuse and even crimes that are committed by cops are more likely to draw scrutiny and public angst. Further, some administrative and legal constraints restrict communication, even statements regarding even high profile incidents, thus further feeding frustrations, pretended or not. There is of course some truth in that analysis, witness the recent rioting and resultant 'run away' criminal activity (Ferguson Mo., Baltimore Md., Chicago III, St. Louis Mo., among others) that emanate from perception, factual or not, regarding police/community relations, but should our police face the

consequences of a communities personal and societal shortcomings relatively isolated, and even when in crisis, in an official silence that implies admission of wrongdoing or even consent to hostility? Is it fair that public rioting, political pressure or even media sensationalism can be a determining factor in how law and justice standards are applied? What other profession is asked to bear this actual and potential hideous personal burden (and all at an insulting 1% compensation offer, giving the current 'American 1%' political debate a whole new satirical perspective)? How far of providing a comfort zone for politicians avoiding blame is too far? Ditto some police executives. Indeed, is there any rationale that excuses shameless scapegoating of anyone, particularly to those critical to our societies well being, effective and still expect performance?

What about Legal Recourse?

Note that in Chicago a police officer subjected to an assault with a baseball bat has sued the estate of the deceased perpetrator (from funds garnered as settlement from the city that succumbed to what some regard as a shakedown) for damages regarding suffering by the officer, both physical and emotional. All eyes should be following this path to redemption and poetic justice, especially by those in a position to do so. Lastly, people responsible for promoting, permeating or protecting (1st Amendment issues aside) these blatant and harmful unfounded accusations deserve attention and steps towards accountability. Legal precedence and relief is one answer; public confrontation, including from, first and foremost, public officials. then police managers, union reps., and

Going West From Long Island


